### NOTIFICATION

The 28th December 2007

No. 60906—PDA-I.- 104/2007 (Pt. III)-D. & A.—In exercise of the powers conferred by Section 9 of the Orissa Urban Police Act, 2003 ( Orissa Act 8 of 2007), the State Government do hereby constitute the following two Police Districts and one Traffic District and divide the districts into Subdivisions within the jurisdiction of the Police Commissionerate created under Section 4 of the Act indicating the Police Stations coming under each Subdivision as mentioned against each :—
