COMMISSIONER'S ORDER NO.04/2012

State Government vide Home Department Notification No.PDA-II-170/2008-12624/D&A dtd.02.03.2009 have declared the Commissioner of Police, Bhubaneswar-Cuttack, to be the Licensing Authority under the Odisha Cinemas (Regulation) Act, 1954 (Odisha Act, 2 of 1954) within the territorial jurisdiction of Police Commissionerate, Bhubaneswar-Cuttack. In order to physically verify as to whether provisions of Odisha Cinemas (Regulation) Rules, 1964 are being strictly complied with by the Cinema Hall owners/proprietors or not and in accordance with Clause 2 (a) of Rule 8 of Odisha Cinemas (Regulation) Rules, 1964, a Board is required to be constituted to inspect the Cinema Hall premises.

By virtue of powers conferred on the undersigned u/s 5 of the Odisha Cinemas (Regulation) Act, 1954 and Clause 2 (a) of Rule 8 of Odisha Cinemas (Regulation) Rules, 1964, a Board is hereby constituted, comprising the following officials of Bhubaneswar and Cuttack under the Chairpersonship of Commissioner of Police, Bhubaneswar-Cuttack, Licensing Authority.

1. Addl. Commissioner of Police, Bhubaneswar-Cuttack
2. Dy. Commissioner of Police, Bhubaneswar/Cuttack, as the case may be
3. Executive Engineer R&B of respective jurisdiction
4. Executive Engineer PH of respective jurisdiction
5. Executive Engineer Electrical of respective jurisdiction
6. Asst. Fire Officer, Bhubaneswar/Cuttack
7. Representative of Bhubaneswar/Cuttack Development Authority
8. Representative of Bhubaneswar/Cuttack Municipal Corporation.

Further, by virtue of powers conferred on the undersigned u/s 5 of the Odisha Cinemas (Regulation) Act, 1954 and Clause 4 (a) of Rule 8 of Odisha Cinemas (Regulation) Rules, 1964, a Sub-committee is hereby constituted comprising the

following officials under the Chairpersonship of the Addl. Commissioner of Police, Bhubaneswar-Cuttack to undertake inspection/visit of building and submission of report/recommendation(s) for grant of permanent licence to the Cinema Hall/Multiplex.

2. Executive Engineer R&B of respective jurisdiction
3. Executive Engineer PH of respective jurisdiction
4. Executive Engineer, Electricals of respective jurisdiction

7. Representative of Bhubaneswar/Cuttack Municipal Corporation.
