COMMISSIONER'S ORDER NO. 06 / 2009

Whereas on 02.03.09 Election Commission of India, announced the schedule for holding the General Elections, 2009. Whereas Election Commission of India has directed to issue Prohibitory Orders under section 144 CrPC, banning carrying of licensed arms as soon as election is announced and that should be effective till the declaration of election results vide its letter No.464/L&O/2007/PLN-1 dtd.08.01.2007 and letter No.VF(A)-28/2009/ 2212/Elect dt03.03.09.

2. And whereas reports have been received that large number of rallies, processions, demonstrations, propaganda, meetings in election campaign are likely to be held within the jurisdiction of the Police Commissionerate, Bhubaneswar-Cuttack. In order to maintain law & order for smooth and peaceful conduct of free and fair election, it has become absolutely essential to issue Prohibitory Order u/s 144 CrPC in Police Commissionerate, Bhubaneswar-Cuttack area, banning carrying of licensed arms, as carrying of the same will cause danger, panic or havoc in the minds of general public during the ensuing election and the carrying of arms may disturb public peace and tranquillity.

3. And whereas it is necessary to take speedy measures in this behalf to prevent danger to human life or safety and disturbance of public tranquillity.

4. Now, therefore, in exercise of the powers conferred upon me u/s 144 CrPC, 1973 vide Government of Orissa Home Department Notification No.60901/D&A

dtd.18.12.07, I, Sri B.K.Sharma, Commissioner of Police-cum- Executive Magistrate do hereby pass this order/pronounce this order prohibiting carrying of licensed arms within the jurisdiction of Police Commissionerate Bhubaneswar-Cuttack.

5. This order shall come into force with effect from 09.03.09 and shall remain in force for 60 days i.e., up to 07.05.09 (both days inclusive) unless withdrawn earlier.

6. As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. It shall be published for the information of public through Press and by affixing copies on the notice boards of my office and the offices of DCsP, Cuttack/Bhubaneswar, Addl. DCsP, ACsP, Collector, Cuttack, Collector, Khurda, ADM, Bhubaneswar, Sub Collector, Cuttack, Sub Collector, Bhubaneswar, Tehsil Offices concerned, all Police Stations concerned, the offices of the Bhubaneswar Municipal Corporation and Cuttack Municipal Corporation, the offices of Choudwar Municipality, Jatni Municipality, Gram Panchayat Offices and Revenue Inspector's Offices.
