COMMISSIONER'S ORDER NO. 3 /2016

In supersession of Commissioners Order No.10/2009 issued vide Memo No.934/CP-Lic. Dt.16.4.2009 and in pursuance of Section-28 of the Orissa Urban Police Act, 2003 (Orissa Act 8 of 2007) and regulation 39(2) of Bhubaneswar-Cuttack Police Commissionerate (Traffic & Public Order) Regulations-2008, it is hereby notified that no training to drive motor vehicles shall be imparted by any person or Driving Training Institutions on the following roads of Bhubaneswar city from 8.00AM to 12.00 noon and 4.00PM to 8.00PM.

1. Nalco square to B.P. Airport square via Sainik School, Acharya Vihar and AG Square and vice-versa.
2. Raj Bhawan square to Nandankanana via Jaydev Vihar, NALCO square and KIIT square and vice -versa.
3. Old Airport square to VSS Nagar via Sishubhaawan square, Master Canteen and Vani Vihar square and vice -versa.
4. Raj Bhawan square to Kalpana square and vice -versa.
5. Rasulgarh square to Daya River square via Kalpana, Ravi Talkies square and vice -versa.
6. Raj Mahal square to New Airport square via Forest Park and vice -versa.
7. CRP square to Power House square and vice -versa.
8. Fire training school square to New Airport square via OUAT square and vice -versa.
9. Rupali square to Regional college square and vice -versa.
10. Road from City Women's College to Jagamara square and vice-versa.
11. Khandagiri square to Pokhariput square via Gandamunda square and vice-versa.
12. Khandagiri square to Bharatpur and vice-versa.
13. Old Airport square to Pokhariput square and vice-versa.
14. Ravi talkies square to Siridi Sai square and vice-versa.

Violation of the aforesaid order is a punishable offence under section 96 of Orissa Urban Police Act, 2003 and is compoundable by Police Officers of and above the rank of Inspector of Police, with a minimum fine of Rs.500/- which may extend to Rs.1000/- for each offence, as per Home Department Notification No. 1833/D&A dtd. 15.01.2009.
