Traffic Regulation on "No Parking Zones"

Regulation No. 732 TCP-Judl

Date 13-08-15

In exercise of the power conferred under section 28 (1) of Odisha Urban Police Act 2003 (Act No. 08 of 2007), I Dr. Rajendra Prasad Sharma, Commissioner of Police, Bhubaneswar-Cuttack, do hereby make this traffic regulation under the Act to notify "No Parking Zones" on the intersections of the public roads in both Bhubaneswar and Cuttack city for the interest of public safety and convenience. This regulation is issued for regulating traffic and matters incidental thereto w.e.f dated 16th August, 2015 till further amendment made in this behalf.

- It is hereby brought to the public notice that no two wheelers, motor cycles, scooters etc., three wheelers and other vehicles or carriages of any design shall be allowed to be parked on each side of the centre of intersections of the public roads/streets where sign boards of "No Parking Zone" have been erected.
- It may not be construed to mean that the places other than these "No Parking Zones" are deemed to be parking zones, unless and until specifically notified.
- Accordingly, whoever contravenes, or abets the contraventions of the regulation made under section 28 (1) of Odisha Urban Police Act 2003 (Act No.8 of 2007), shall be liable with fine which may extend to five hundred rupees as per section 96 (d) of the said Act which is compoundable by an officer of and above the rank of Inspector of Police of this Commissionerate.
- For the purpose of this notification, motor vehicle or vehicle as defined under Sec. 2(28) of Motor Vehicle Act 1988 means and includes any mechanically propelled vehicle adopted for use upon roads whether the power of propulsion is transmitted thereto from an external or internal source and includes a chassis to which a body has been attached and a trailer.
- This regulation is issued for the information of the public at large and shall be published in our website, through the press and by affixing copies on the Notice Board of the offices of DCP Bhubaneswar, DCP Cuttack, Tahasil Offices, Zone ACsP and all police stations concerned.
