

AUCTION SALE NOTICE

Sealed tender in plain paper from the intending purchasers are invited by the Commissioner of Police, Bhubaneswar-Cuttack, Bhubaneswar for auction sale of 30 (thirty) nos. of condemned Police vehicles of Bhubaneswar UPD lying at RO Bhubaneswar UPD, 27 (twenty seven) nos. of condemned Police vehicles of Cuttack UPD lying at RO Cuttack UPD, 5 (five) nos. of condemned Police vehicles of Police Commissionerate, Hdqrs., lying in CP, Hdqrs, BBSR and 3 (three) nos. of condemned Police vehicles of OSAP 7th Bn., BBSR lying at OSAP 7th Bn., ground, BBSR on as is where is basis. Unit wise list of condemned Police vehicles will be notified in the Notice Board of RO Bhubaneswar UPD, Notice Board of RO Cuttack UPD, Notice Board of Police Commissionerate Hdqrs., Bhubaneswar and Notice Board of DCP(Armed), OSAP, 7th Bn., Bhubaneswar after the publication of tender in the news paper for information of the bidders. The intending bidders may inspect the vehicles during office hours from 11AM to 5 PM where the vehicles are available.

The Sealed Tender will be received latest by 5 PM on 16.10.2017 and will be opened on 17.10.2017 in Office of DCP, (Hdqrs.) Bhubaneswar in the presence of the available tenders or their agents. For the purpose of receiving the tenders, a sealed box will be kept at Police Commissionerate Headquarters, Bidyut Marg, Bhubaneswar. The intending bidders are required to pay a sum of Rs 1000/- (Rupees one thousand only) for each vehicle as earnest money deposit in favour of Addl. DCP, (DDO-I), O/o the Commissioner of Police, Bhubaneswar-Cuttack, Bhubaneswar payable at Govt. Treasury Branch, Bhubaneswar along with the tender paper. The amount offered by the bidders should be written clearly in words and figures against each vehicle and the bidding amount must be more than the upset price fixed. Any deviation in stating of facts and figures shall make the tender liable for rejection. The tender papers should be sent in sealed envelope with present address for correspondence. The successful bidders shall be liable to pay MV Tax, if any, outstanding against the vehicles as well as GST as applicable will be charged extra on the bidding amount. The highest bidder will have to deposit 25% of offered amount against each vehicle on the spot in shape of draft or cash and the remaining amount within 7(seven) days after issue of the intimation letter, failing which the earnest money deposit against the vehicles will be forfeited without assigning any reason, Tools, equipments and spare parts will not be delivered with the vehicles.

The vehicles will be delivered as is where is basis and the bidders shall remove the vehicles from the site within 7(seven) days from the issue of release order at their own cost. After delivery of the vehicles, the custody and security of the vehicles shall be the responsibility of the bidders. No complaint and claimed on this account will be entertained on fellow to remove the vehicles within the aforesaid stipulated period. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site. The authority reserves the right to accept/reject any or all tenders without assigning any reason thereof. No complaint will be accepted after finalization of the tender.

TERMS AND CONDITIONS.

1. After the acceptance of the highest bid, the highest bidders shall have to deposit 25% of the accepted highest bid amount immediately on the spot and the rest 75% within 7 days from the date of receipt of the ratification/confirmation of the price. Highest bid below the approved upset price shall have to be referred to the competent authority.
2. In case the highest bidder fails to deposit the balance 75 % of the bid amount within the stipulated period, earnest money along with 25% of the bid amount deposited on the spot on the date of auction sale shall be forfeited to government without making any correspondence to the person concerned and the vehicle will be put to fresh auction sale.
3. The vehicles shall not be delivered to the highest bidder till full payment is made and other formalities are complied with. No tools, equipments or spare parts will be delivered.
4. The highest bidder is liable to pay MV tax, if any outstanding against the vehicles as well as GST as applicable will be charged extra on the bidding amount.
5. The highest bidder shall remove the vehicles from the spot within 7 days from the date of full payment of highest bid amount failing which no claim/compliant of any sort shall be entertained in this regard. The highest bidder shall be responsible for safe custody of the vehicle after the aforesaid period.
6. The highest bidder shall be charged ground rent of 1 % of the bid amount against each vehicle per day or part of the day, if he fails to remove vehicles from the stipulated period from the site.
7. Where the ground rent exceeds the highest bid amount (sale price) deposit, the highest bidder ceases to have any claim on the vehicles. The sale price deposited will be adjusted towards ground rent and the vehicle will become the absolute property of govt. and will be deposited off by fresh tender sale.
