**PROCLAMATION FOR DISPOSAL OF UNCLAIMED VEHICLES/ PROPERTY UNDER  
SECTION 62 OF ODISHA URBAN POLICE ACT 2003.**

Notice is hereby given as required U/S- 62 of Odisha Urban Police Act 2003, that unclaimed property like Vehicles as mentioned below are lying in the premises of different offices/Police Posts of Police Commissionerate, Bhubaneswar - Cuttack and will be sold on public auction. In this regards wide publicity has been made in 2 (two) Odia Daily Newspapers and 1 (one) National Newspaper through Director I & PR Deppt. Bhubaneswar on 01.08.2015 and by uploading the proclamation in Odisha Police website in URL as "Odisha Police >> Whats New on 27.07.2015 for information of general public by giving details of such unclaimed Vehicles with a request to establish their claim if any within a period of 6 months. On this proclamation no members of general public has come forward to establish their claim over the vehicles within the stipulated period. The Vehicles will be sold by public auction and the sale proceeds will be credited to the Government.

Any person intends to inspect any property mentioned below shall be allowed on any day except public holidays between 11 AM to 2 PM at the respective Police Posts mentioned against each Vehicle. Sealed tender in plain paper from the intending purchasers are invited by the Commissioner of Police, Bhubaneswar-Cuttack, Bhubaneswar for auction sale of 60 (sixty) nos. of unclaimed vehicles of Cuttack UPD on as is where is basis.

**Tender will be received latest by 5 PM on 16.08.17** and will be opened on the next day i.e. on 17.08.17 at 11 AM in the office of the DCP ,Hqrs, Bhubaneswar-Cuttack, Bhubaneswar in the presence of the available bidders(s) or their agent(s) by the auction sale Committee. The intending bidder(s) are required to pay a sum of Rs1000/- (Rupees one thousand) only for each vehicle as earnest money deposited with the tender paper in the shape of Bank Draft in favour of DCP ,Hqrs, Bhubaneswar-Cuttack, Bhubaneswar, payable at SBI, Govt. Treasury Branch, Bhubaneswar.

The amount offered by the bidder(s) should be written clearly in words and figures against each vehicle. Any deviation in tender and stating of facts and figures shall make them liable for rejection. The tender should invariably be sent in a sealed envelope with the present address for correspondence. The successful bidder(s) shall be liable to pay MV Tax, if any, outstanding against the vehicle. The successful bidder will also be liable to pay TAX on the bidding amount on such rate as admissible. The highest bidders will have to deposit 25% of the offered amount against each vehicle on the spot in shape of draft or cash and the remaining amount within 7(seven) days after issue of the intimation letter, failing which the earnest money deposited against the vehicles will be forfeited without assigning any reason thereof. Vehicles put to this auction sale do not include tool kits .The vehicles will be delivered on as is where is basis and the bidder(s) shall remove the vehicles from the site within 7(seven) days from the issue of release order at their own cost. After delivery of the vehicles, the custody and security of the vehicles shall be the responsibility of the bidder(s). No complaint and claim on this account will be entertained on failure to remove the vehicles within the aforesaid stipulated period, Ground rent @ 1% of the bid amount against each vehicle shall be charged for each day or part of the day till removal of the vehicles from the site. The authority reserves the right to accept/reject any or all tenders without assigning any reason thereof. No complaint or rejection, in any, form will be accepted after finalization of the tender.

## TERMS AND CONDITIONS

1. After the acceptance of the highest bid, the highest bidders shall have to deposit 25% of the accepted highest bid amount immediately on the spot and the rest 75% within 7 days from the date of receipt of ratification/confirmation of the price. Highest bid below the approved upset price shall have to be referred to the competent authority.
2. In case the highest bidder fails to deposit the balance 75% of the bid amount within the stipulated period, earnest money along with 25% of the bid amount deposited on the spot on the date of auction sale shall be forfeited to government without making any correspondence to the person concerned and the vehicle will be put to fresh auction sale.
3. The vehicle shall not be delivered to the highest bidder till full payment is made and other formalities are complied.
4. The highest bidder is liable to pay MV Tax, if any outstanding against the vehicles as well as during tax payable on the bidding amount on such rate as admissible on the date of bid.
5. The highest bidder shall remove the vehicles from the spot within 7 days from the date of full payment of highest bid amount failing which no claim/complaint of any sort shall be entertained in this regard. The highest bidder shall be responsible for safe custody of the vehicle after the aforesaid period.
6. The highest bidder shall be charged ground rent of 1% of the bid amount against each vehicle per day or part of the day, if he fails to remove vehicles from the stipulated period from the site.
7. Where the ground rent exceed the highest bid amount (sale price) deposit, the highest bidder ceases to have any claim on the vehicles. The sale price deposited will be adjusted towards ground rent and the vehicle will become the absolute property of Govt. and will be deposited off by fresh tender sale.
