**PUBLIC NOTICE**

Executive Engineer - II, Cuttack of Cuttack Municipal Corporation has proposed to undertake construction of cross-drainage at Upper Telenga Bazar, Cuttack.

As recommended by DCP, Cuttack in his letter No.1893/DIB Dt. 04.05.2017 basing on the feasibility report of ACP, Traffic, Cuttack the work will be completed within 15 days.

By virtue of powers conferred u/s 28 of Odisha Urban Police Act 2003 (Odisha Act 8 of 2007) and in pursuance of Regulation 36 of Bhubaneswar - Cuttack Police Commissionerate (Traffic and Public Order) Regulations 2008, it is hereby notified that the following traffic diversion shall be undertaken for completion of the work within 15 days subject to fulfilling of the conditions as laid down therein by (R&B) Deptt. after announcing through the public address system and creating due awareness among the public in view of public safety and security.

- From Purighat Gada all the vehicles shall be diverted towards Town Hall and CMC office via Ragnath Jew Temple & Odl Devi Durga Hall.
- Similarly from Upper Telenga Bazar Chhak all the vehicles shall be diverted towards Hotel Blue Lagoon (Ring Road) via Sun Shine field.
- From Purighat P.S. Chhak vehicle can avail to CMC office via Ring Road & Sunshine field.

He is requested to undertake the following precautionary measures besides announcing through the public address system and creating due awareness among the public regarding the diversion.

- 01) For information of commuters sign boards like, road closed ahead, Men at work, work in progress, Drive slowly, no parking, must be fixed at different places like Purighat P.S. Gada, Raghunath Jew Temple, Ring Road, Hotel Blue Lagoon, Sunshine Field, Ring Road with proper illumination system shall be placed.
- 02) Specially, 'No Entry' sign board for four wheeler/Three wheeler vehicles must be fixed at the both side of blocking points i.e. Purighat P.S. Gada and Ring Road. Only motor cycle allowed sign board at both the blocking point must be fixed.
- 03) The beginning and closing time of the construction work should be inscribed on the board in bold letter in English and Odiya language for the awareness of general public.
- 04) Required numbers of stop boards must be placed by the applicant at the blocking points/diversion point for better regulation of traffic in consultation with ACP, Traffic.
- 05) Proper illumination must be made at the point where the road will be closed specially near construction work.
- 06) The construction agency should ensure wide publication in all Medias regarding this diversion on the actual date and time.
- 07) They must place hard boards with proper florescent mark by the side of excavation work instead of red nets/tapes at the construction site.
- 08) Construction agency must deploy required numbers of private security personnel/traffic warden in consultation with ACP, Traffic to assist the traffic personnel at blocking points and diversion points.

09) Before diversion of traffic the private security personnel to be deployed by the construction agency should be trained and sensitized regarding their nature of work/duty. They should be provided with red and green torch lights with shining jackets during night hours. At the construction side, 24 hour security personnel to be deployed with red flag till the construction work is completed.


10) Construction agency should take the private security personnel from the authorized agencies so that they are aware regarding their nature of duty.

IV) Copy to ACP, Traffic, Cuttack/ IIC, Traffic PS, Cuttack for information and necessary action with reference to his letter No.433/ACP-Traffic. dt.01.05.2017 addressed to DCP, Cuttack.

Required number of Traffic personnel/ Home Guards of Traffic P.S will be provided from Traffic P.S for general supervision.

V) Copy to ACsP, Zone-II & V, Cuttack/ IsIC, Purighat / Lalbag / Badambadi P.Ss for information and necessary action.
