**PUBLIC NOTICE**


In the meeting held under the chairmanship of Hon,ble Minister of State(Ind. Charge), Tourism & Culture. Govt. of Odisha, it has been decided to hold Raahgiri day programme on Janpath from Master Canteen chowk to Ram Mandir square every Sunday morning from 6.30 AM to 10.30 AM starting from 17<sup>th</sup> January, 2016. For the purpose the above mentioned stretch of the Janpath needs to be closed to vehicular traffic from 6.30 AM to 10.30 AM on every Sunday.

By virtue of powers conferred u/s 28 of Odisha Urban Police Act 2003 (Odisha Act 8 of 2007) and in pursuance of Regulation 36 of Bhubaneswar - Cuttack Police Commissionerate (Traffic and Public Order) Regulations 2008, it is hereby notified that the road from Master Canteen chowk to Ram Mandir square will remain closed for all kinds of motor vehicles on every Sunday morning from 6.30 AM to 10.30 AM starting from 17<sup>th</sup> January, 2016.

All kinds of motor vehicles from Master Canteen side intending to go to Ram Mandir side shall be diverted to PMG square and then take right turn to Housing Board sqr. and then take right turn to Ram Mandir square.

Similarly all kinds of motor vehicles coming from Vani Vihar side shall be diverted either at Big Bazar sqr. to go to Cuttack Road or at Ram Mandir sqr. to go to Housing Board sqr. and from thereafter to Master Canteen.

Violation of the instant order is an offence punishable u/s 96 of the Odisha Urban Police Act 2003 and is compoundable by an officer of and above the rank of Inspector of Police with a minimum fine of Rs.500/- which can extend up to Rs.1000/-.
