PUBLIC NOTICE

M/s L&T Limited, Cuttack proposes to undertake construction of sewerage work for Cuttack from Mustan Dargha Chhak to Mani Sahoo Chhak requiring permission for diversion of traffic for a period of 30 (Thirty) days.

DCP, Cuttack recommended vide his letter No.2627/DIB Dt.24.7.2015, that there is need for closure of road for which traffic in respect of three/four wheelers and other heavy vehicles are to be diverted for smooth flow of traffic from Mustan Dargha Chhak to Mani Sahoo Chhak for a period of 30 days on the basis of feasibility report of ACP, Traffic, Cuttack for the purpose of safety and security of commuters.

By virtue of powers conferred u/s 28 of Odisha Urban Police Act 2003 (Odisha Act 8 of 2007) and in pursuance of Regulation 36 of Bhubaneswar - Cuttack Police Commissionerate (Traffic and Public Order) Regulations 2008, it is hereby notified that the following traffic diversion shall be undertaken for completion of the project work requiring 30 (Thirty) days subject to fulfilling of the conditions as laid down therein by M/s L&T Limited after announcing through the public address system and creating due awareness among the public by wide publication in medias.

1. All four /three wheeler vehicles coming from Machhua Bazar & Matamatha Chhak side intending to go to Buxibazar Chhak via Mani Sahoo Chhak shall be diverted from Mustan Dargha Chhak straight towards Girner Hotel chhak and then take left turn up to Mani Sahoo Chhak and then proceed to Buxibazar.
2. All four /three wheeler vehicles coming from Buxibazar Chhak / Fire station chhak side intending to go to Machhua Bazar & Mangalabag Chhak shall be diverted from Mani Sahoo chhak to take left turn towards Girner Hotel chhak and then right turn up to Mustan Dargha chhak then go straight up to Machhua Bazar & Mangalabag chhak.

All four/three wheeler vehicles coming from Machhua Bazar Sahi intending to go to Mustan Dargha chhak shall come up to Mani Sahoo Chhak then take right turn up to Girner Hotel chhak then right turn to Mustan Dargha chhak.

During execution of the project work 06 (six) feet of road shall be kept open for pedestrian as well as for passing of two wheelers.

He is requested to undertake the following precautionary measures besides announcing through the public address system and creating due awareness among the public regarding the diversion.

- 1) The beginning and closing time of the construction work should be inscribed on the boards in bold letter in English and Odia for the awareness of commuters.
- 2) Road closed/ Men at work/Work in Progress/Drive slowly/No Parking sign boards must be fixed at different turning points like Mani Sahoo chhak, Mustan Dargha chhak & Girner Hotel Chhak and both the side of the blocking points with proper illumination.
- 3) Proper illumination must be made at the point where the road will be closed, specially at both side of the blocking points specially at Mani Sahoo chhak Chhak and Mustan Dargha Chhak.
- 4) Before diversion of vehicle, the Traffic Marshalls are to be deployed for the purpose should be trained and sensitized properly regarding their nature of work/duty. They should be provided with red and green torch lights with shining jackets during night hours. They will work with traffic police. At the construction site, 24 hours security personnel of the company should be deployed with red flags till the construction work is completed.
- 5) The company should produce the road digging permission from the competent authority before commencement of work.
- 6) 10 nos. of Traffic Marshalls with 10 nos. Jackets and Torch lights are to be provided by the company.

- 7) No entry sign board for four/ three wheelers must be fixed at both sides of blocking points.
- 8) The company must develop the road condition of the diversion road.
- 9) They must place hard boards with proper florescent mark by the side of excavation work instead of red nets/ tapes at the construction site.
- 10) Required numbers of Stop boards must be placed by the company at the blocking point/ diversion point for better regulation of traffic.
- 11) The construction work should be started after complying all the above points and intimating ACP, Traffic and local P.S.
- 12) Flex boards with left/ right turn indication should be provided at each turning point.
- 13) The construction company should ensure wide publication in all media regarding this diversion on actual date and time.
- IV) Copy to ACP, Traffic, Cuttack/ IIC, Traffic PS, Cuttack for information and necessary action with reference to his letter No.538/ACP-Tr. dt.20.7.2015 addressed to DCP, Cuttack.
- 04 numbers of Traffic personnel / Home Guards of Traffic P.S proposed by DCP, Cuttack to be provided from Traffic P.S.
- V) Copy to ACP, Zone-II, Cuttack/ IISc, Mangalabag P.S/ Cantonment P.S for information and necessary action.
- VI) Copy to PRO, Commissionerate Hdqrs./Programming Cell for information to cause wide publicity in the interest of public information.
