

**PUBLIC NOTICE**

In accordance with direction of Deputy Registrar, (Administration and Protocol), Hon'ble High Court, Odisha vide his letter No.4601 dt.7.11.2014 and letter No.3198 dt.27.5.2015 basing on the proposal received from Manager, L&T Construction, Water & Renewable Energy and ACP Traffic, Cuttack, DCP, Cuttack has proposed vide his letter No.1986/DIB. Dt.1.6.2015 for fixing of alternative VIPs route from Chandi Chhak to Odisha High Court for smooth passage of vehicle of the Hon'ble Judges as well as free movement of vehicular traffic in view of ongoing construction of sewerage network by M/s L&T Limited on the VIPs route of Hon'ble Judges from Chandi Chhak to Chandinichowk Chhak.

Therefore by virtue of powers conferred u/s 28 of Odisha Urban Police Act, 2003 (Odisha Act 8 of 2007) and in pursuance of Regulation 36 of Bhubaneswar-Cuttack Police Commissionerate (Traffic and Public Order) Regulations 2008, it is notified that the traffic diversion of traffic as suggested by ACP (Traffic) will be undertaken from Chandinichowk Chhak to Chandi Chhak to Odisha High Court for smooth passage of vehicles of the Hon'ble Judges via Kanika Chhak, Shelter Chhak, Mohantypara, Dagarpada and Chandichowk, so as to facilitate the M/s L&T Limited to undertake the project work on the stretch between, Chandi Chhak to Chandinichowk. As per the direction of Hon'ble High Court, the project work will be completed by M/s L&T Limited on the street between Chandi Chhak to Chandinichowk by 30.09.2015 in providing sufficient manpower, illumination, adoption of sufficient safety measures etc. during the time of construction work for efficient management of traffic.

Violation of the instant order is an offence punishable u/s 96 of the Odisha Urban Police Act, 2003 and is compoundable by an officer of an above the rank of Inspector of Police with a minimum fine of Rs.500/- which can extend up to Rs.1000/-
