Promulgation of Order U/s 144 CrPC

ORDER No. 06 /CP-Judl.

Date. 12.09.16

Whereas it has come to notice that landlords / owners / partners / proprietors have let out their buildings for the purpose of private residential hostels or common mess for women of schools, colleges, technical educational institutions or for working women without ensuring proper safety and security measures which facilitates anti-socials, hooligans and criminal elements to commit or attempt to commit, abet or conspire to commit crime against women boarders i.e outrage of modesty using criminal force, assault, stalking, disrobing, unwelcome physical contact, voyeurism etc. It is apprehended that there is every likelihood of imminent danger to the life and safety of women boarders, resulting breach of peace and disturbance of public tranquillity.

And whereas, it is necessary that some checks should be put in place to deter these anti-socials, hooligans and criminals from committing or attempting to commit or abetting or conspiring to commit any such offence towards the women boarders. There is sufficient ground for proceeding under the law for immediate prevention and speedy remedy.

The State Govt. in exercise of the power under sec 58 (1) (a) of Odisha Urban Act 2003 (Odisha Act 08 of 2007), have conferred upon the undersigned vide Notification No.60901 / D&A dt. 28.12.2007 power of District Magistrate and Executive Magistrate under Code of Criminal Procedure 1973; and accordingly, by virtue of Section 144 Cr.P.C., 1973 (No.2 of 1974), I, Sri Yogesh Bahadur Khurania, IPS,

Commissioner of Police, Bhubaneswar-Cuttack, do hereby make this written order for strict compliance by landlords/owners/ Partners/proprietors of such women's hostel/mess, located in Bhubaneswar and Cuttack Urban Police Districts under this Commissionerate within a period of O2 (two) months from the date of publication of this order.

- In case any landlord/owner/ partner/proprietor has let out his/her building to five or more women of schools/ colleges/technical educational institutions or to the working women, it would be deemed as private residential hostel/ Common Mess for women; and accordingly such landlord/owner/ Partner/proprietor shall ensure adequate security measures all around the women's hostel/ common mess in the shape of strong boundary walls, grill gates, doors, windows etc. so that such hostel or common mess would be physically secured; and anti-socials may not find easy access to such hostel/mess.
- 2) The landlord /owner/ partner/proprietor may engage private security guards, from licensed Security Agency to augment the security of such women's hostel/common mess if deemed necessary.
- 3) The landlord / owner / partner / proprietor shall install appropriate number of good quality CCTV surveillance cameras with recording system to capture the image of the outer areas of at least 30 (Thirty) meters distance all around such residential hostel/ mess taking due precaution not to breach the privacy of the women inmates during installation and operation of such CCTV cameras. In case any defect in the functioning of the CCTV system is noticed immediate action be taken to get it rectified.
- The landlord / owner / partner / proprietor shall preserve CCTV footage for a period of at least thirty days (30), and shall cause production of the CCTV coverage on a CD/ pen drive to the police whenever required for the purpose of verification /enquiry/ investigation. He shall ensure that no part of the CCTV footage or any copy thereof, is disclosed to any person/agency without prior approval of the concerned territorial DCsP.
- 5) The landlord /owner/ Partner/proprietor shall submit detail information of the women's hostel/ common mess to the Inspector-in-charge of the concerned police

station as per Form No-1 (Brief description of Residential women's hostel/common

mess) enclosed herewith.

6) He shall maintain one "Inmate Register" in Form No-2 for Women Boarders

and one "Visitors' Register" in Form No-3 (enclosed) to guard against entry of

unauthorised persons into such hostel or mess.

7) In case any illegal or suspicious activities are noticed within the hostel/common

mess premises or in the vicinity, the same shall be forthwith informed/reported to the

Police Control Room at telephone No. 100 and also to the nearest Police station.

This order shall come into force with effect from the 16 th Sept, 2016

and shall remain in force for a period of 60 days i.e. up to 14 th Nov, 2016 (both days

inclusive) unless withdrawn earlier. Any landlords/owner/ Partner/proprietor of such

hostel/mess contravening this order, shall be punishable under Section 188 of Indian

Penal Code.

As the notice cannot be served individually on all concerned, the order is

hereby passed ex-parte. It is being promulgated for the information of the public at

large and shall be published through the press and by affixing copies on the Notice

Board of the offices of DCP Bhubaneswar, DCP Cuttack, Tahasil Offices, all police

stations concerned and Zone ACsP.
