ORDER

Promulgation of Order U/s 144 Cr PC

Whereas it has been directed by the State Government vide order No.3057/R&DM(DM), Dt. 01.06.2020 at para 6 which reads interalia ; "Movements of individuals shall remain strictly prohibited between 7.00 PM to 5.00 AM throughout the State, except for essential activities. The District Collectors/Police Commissioner, Bhubaneswar-Cuttack shall issue orders, in the entire area of their jurisdiction, under appropriate provisions of law, such as under section 144 of CrPC, and ensure strict compliance. "

And whereas, further it has been directed by the State Government in partial modification of the order No.3057/R&DM(DM), Dt. 01.06.2020, keeping in view of "Raja Festival" it is hereby that ordered that the night curfew on FRIDAY, the 12<sup>th</sup> June,2020 will be effected from 10.00 P.M. instead of 07.00 P.M. in order to enable people to do their pre-festival shopping.


All other conditions of the order No.3057/R&DM(DM), Dt. 01.06.2020 and subsequent amendments thereto shall remain unchanged.

And whereas, there is an urgent need to avoid danger to human life, health or safety posed by the spread of COVID-19 pandemic.

Now, therefore, in exercise of the power conferred by the Government of Odisha, Home Department under sec 58 (1) (a) of Odisha Urban Act 2003 ( Odisha Act 08 of 2007 ) upon the undersigned, I, Dr. Sudhanshu Sarangi, IPS, Commissioner of Police, Bhubaneswar-Cuttack, do hereby direct that movement for all non-essential activities in the jurisdiction of the Police Commissionerate, Bhubaneswar-Cuttack shall remain strictly prohibited between 10.00 PM dtd. 12.06.2020 to 5.00 AM dtd. 13.06.2020.

It is further ordered that, all other conditions of the order No.687/CP-Judl. Dtd. 01.06.2020 prohibiting movement of all non-essential activities in the jurisdiction of the Police Commissionerate Bhubaneswar-Cuttack between 07.00 P.M. to 05.00 A.M. till 30.06.2020, shall remain unchanged.

As the notice cannot be served individually on all concerned, the order is hereby passed *ex-parte*. It is being promulgated for the information of the public at large and shall be published through the press and by affixing copies on the Notice Board of the offices of DCP Bhubaneswar, DCP Cuttack, Tahasil offices, all Police stations concerned and Zone ACsP.
