No. 29382-PDA-II-11/2008/D&A— In exercise of the powers conferred U/s 115 of the Orissa Urban Police Act, 2003 (Orissa Act 8 of 2007) the Government do hereby specify the Police Authorities competent for compounding an offence punishable U/s 84 of the Act within the territorial jurisdiction of the Police Commissionerate, Twin Cities Bhubaneswar and Cuttack and the amount and place for collection of the same in the table specified below if the abettor/contravener/offender of Section 65 to 83 of the Act pays the amount on demand to the concerned official on duty.
