Sub: Amendment of Provisions of rule 92 of Police Manual Rule, 1940.

Sir,

I am directed to say that as per existing provisions prescribed under Rule, 92 of the PMR-1940, a fee of Rs.4/-(Rupees four) only is being charged for verification of the antecedents of candidates in each case referred to by a local body or corporation, Private Company, Farm or Person for employment under the respective organisations.

After careful consideration, it has been decided by the Government that Rs.50/-(Rupees fifty) only shall hence forward be charged as the fee for verification of antecedents in each case referred to by a local body or Corporation, Private Company, Farm or person instead of Rs.4/-(Rupees four). A form(Annexure) is prescribed to refer verification of antecedents by the above private institutions. An extra fee of Rs.30/-(Rupees three) only in each case shall be charged for antecedent verifications through e-Seve Centre under the Commissionerate Bhubaneswar-Cuttack jurisdiction.

The existing provisions of Rule 92 of the PMR 1940 are being amended to the above extent.
