## **ADVISORY**

Whereas the Government of Odisha vide Order No.2328/R&DM(DM) dtd.01.05.2021 has decided to impose Lockdown with effect from May5, 2021(Wednesday) till 5:00 AM of May 19,2021(Wednesday) throughout the State. and complete shutdown on weekends, starting 6:00PM of Fridays till 5:00 AM of Mondays.

In the above mentioned order, the Government has prohibited few activities, whereas allowed some activities during the course of lockdown as well as weekend shutdown. For example, the Government has allowed IT and IT enabled service with a maximum 50% staff, operation of plantation at maximum 50% workers, Industries and industrial establishments, its corporate offices up to 30% of staff strength, offices of private / civil society sector officers at maximum 33% staff strength. The Government in the above order has directed the heads of industrial units/corporate offices to convey the Municipal Commissioner and concerned DCsP the numbers of personnel allowed to operate.

In the field, we have observed that the members of these organizations are moving showing their identity proof without any supporting

document that they have been allowed to work, whereas as per guidelines only certain percentage of employees are to be allowed to move to their respective offices. In such circumstances, it is experienced that large number of movements are taking place in violation of Covid Protocol. Therefore, it is, requested that the heads of private Industries/organization/financial establishments who have been permitted to function with restrictions are requested to issue authorization to their employees to move from their places of residence/stay to their offices which they need to produce at the time of checking. They are also requested to furnish the detailed list of employees permitted to concerned DCP offices for reference. This will help police in enforcing Lockdown restrictions imposed by Govt.

As the advisory cannot be served individually on all concerned, it is hereby circulated for the information of the concerned through electronic, print and social media.
